Please note the following rules:

1. Participants must be entering grades 7-12 in the fall of 2018 to participate.
2. A physical permission slip must be signed by parent/guardian and returned to your local Chippewa River District Library branch by **Tuesday, July 24**. Once permission slips are received, staff will register the attendee for the event.
3. Teens must be in the building by 15 minutes after the start of the event when the doors are locked, or they will not be admitted. Pick-up will begin 15 minutes prior to the end of the event and they must be picked up promptly at the end of the event. *I understand that the police will be called for any teens not picked up by 1/2 hour after the publicized finish time of the event.*
4. CRDL teen after-hours events will be co-ed.
5. There will be adequate adult supervision. Adults will be responsible for certain areas of the library at all times.
6. Chippewa River District Library and Mt. Pleasant Parks & Recreation are not responsible for any damaged, lost or stolen property.
7. Photos & videos may be taken of the event and used by CRDL for promotional purposes.
8. If teens wish to play Minecraft and do not have an account, the library will check out accounts to qualifying participants on a first come, first served basis.
9. For our overnight event, teens may bring sleeping bags and pillows. There will be sleeping areas separated by gender.
10. Teens should wear comfortable clothing, as there will be no changing of clothes!
